### d) Cellar Hill

The Chairman reported that the owners of the orchard behind The Dover Castle have amended their application to the Land Registry for the full width of the access from Cellar Hill, currently unregistered, to be registered in their name. The application is now restricted to a small parcel of land within the fence. LKPC had not objected to the revised application.

# 13a Pumping station upgrade-Update

The Chairman informed the members that the Lynsted pumping station was on the list for refurbishment and would be carried out when funds where available. All incidents to be reported and logged.

### 13b Traffic calming in Lynsted-KCC HIP update/Speed Watch update

Cllr Morgan had submitted a new HIP to KCC however most of her suggestions put forward would not be supported as no funding was available. KCC had agreed to supply & fit new school signs to existing posts. KCC has agreed to send Cllr Morgan a 30mph Toolkit to help to promote the reduction in speed through the village. Any preventive rules for stopping Lorries from going through village were very difficult to enforce. Building work on Tonge Golf Range has now finished which should reduce the lorry movements.

#### 13c APM/Fete-Review

The APM had been very well attended with 27 members of the public present along with the LKPC members making approx. 35 people. The feedback has been positive. The APM for 2023 would be held in June. A decision to attend Lynsted Fete again would be taken nearer the time next year

#### 13d Waste Bin Tickham

The Clerk informed the members that the dog waste bin had now been installed at the original requested location

#### 13e Dog Waste bin signs Batteries Close

The Clerk had emailed SBC and requested a sign be erected after a request from a resident of Batteries Close complaining about the amount of dog waste on the ground, even though there was a waste bin available.

### 13f Kingsdown Village Gate

The Clerk informed the members that both Kingsdown village gates were now in position and the residents of Kingsdown were very happy with them.

#### 13g Footpath map/Noticeboard refurbishment

The Clerk informed the members that the new map stand was now in situ and the noticeboards at Lynsted & Kingsdown had been refurbished.

#### 13h Church Wall

After corresponding with SBC temporary repairs had been carried out to the church wall until a full repair can be completed. After further consultation LKPC were in agreement with the leader of SBC Mike Baldock, that the wall should be repaired like for like using traditional methods and materials. However KCC wanted to rebuild the wall using concrete with flint added afterwards.
