7. Update from Borough Councillors

SBC budget for 2024/25 goes to full council for approval in Feb 2024. It is proposed to increase parking charges in SBC car parks from April 2024

Frognal Place - the application for the building of 300 houses was imminent. Southern Water say they cannot cope with more than 50 houses on their present infrastructure. The provision of GP facilities to be discussed in December with Helen Whately MP and the NHS.

Roadworks along A2 and Lower Road are ongoing causing disruption to residents.

Planning rules may be amended by SBC, restricting power of Parish Councils to 'call in' applications to committee. Details to follow

The Level crossing in Teynham at Orchard View end – KCC voted to keep the crossing open. Network Rail likely to appeal

Lynsted church were setting up a community project called 'Grow Baby' where new and used baby items are donated and recycled for further use. It is hoped to be launched in Feb 24. Cllrs Speed, Bowen and Lehmann had each donated £500 from their members' grants.

Cllr Speed is investigating a Rural Carbon Footprint Reduction grant for LKPC to replace their 41 streetlights with LED lights. To be advised if application is successful

Church wall - SBC had placed an order with a structural engineer to provide a design for approval by KCC. Timeframes for the work to be carried out TBA

The Conservative group at KCC voted against proposals for the closure of Household Waste Recycling Centres, including Faversham. No official decision has been made and the proposals have merely been paused.
